

EU Research Trends - October 2016

Trends

Commission reveals initial thoughts on FP9

During a conference at Science Business in Brussels on 12th October, the Director-General for DG Research and Innovation Robert-Jan Smit sketched the process and the initial thoughts that will lead up to FP9. A foresight study (BOHEMIA) is underway and a public consultation on the interim evaluation of Horizon 2020 is now open to prepare the ground for the next framework programme. H2020 is seen by DG Research and Innovation to have done a good job and therefore evolution rather than revolution is to be expected when moving from H2020 to FP9. The Director-General and several of his staff repeated that FP9 will be co-designed with its stakeholders which is why the Commission urges all stakeholders to participate in the consultation. LERU publishes interim evaluation of Horizon 2020

During a public event on Friday 21. October the League of European Research Universities presented its interim evaluation of Horizon 2020. The launch event was well attended by both prominent audience as well as the Commission. LERU's interim evaluation of H2020 holds praise for H2020 but also pinpoints weaknesses and offers suggestions as to address these weaknesses. Main praise points were: Praise for ERC and MSCA, praise for efforts done for simplification as well as for measures relating to collaborative research. Main concerns were related to oversubscription, the problem with widening the EU research as well as the



credibility of evaluation procedures and lack of transparency. The LERU paper can be consulted here.

LERU will in the coming weeks publish several other papers. On 7th November a paper on Citizens' Science will be published on 14. December, a paper on Interdisciplinarity and in 2017 a report will come from LERU on assessing research impact.

The Austrian Government think tank on FP9

The Austrian Government think tank has published a position paper on FP9. The paper calls for simpler rules, more robust evaluation and better access to the framework programme for non-EU researchers. The Austrian FP9 paper can be downloaded here.

The EU budget 2017

The European Parliament Budget Committee reversed all the cuts proposed by the Council on the draft 2017 budget and added additional budget lines to fight youth unemployment and increased spending on research and infrastructure. MEPs also reiterated their demand to negotiate the MFF mid-term revision jointly with the EU's budget for 2017, as the decisions on the former are expected to be integrated into the latter.

Collaboration 'at risk' from data protection laws

Research Europe are reporting that lawyers and researchers are concerned about the General Data Protection Regulation (GDPR) that allows member states to make their own decision on how personal data is used in research, which, they say, could undermine collaboration. The regulation, due to come into force in May 2018, is intended to harmonise EU laws—making it easier for groups including researchers to meet the necessary standards. But amendments introduced during years of negotiations could in fact result in different rules in different member states, causing problems for research organisations.

"Member states can maintain divergent standards on data pseudonymisation and can also impose diverging safeguards for the processing of health and genetic data," says Sigrid Achenbach, a lawyer and a member of the Data Protection Working Group of the European Federation of Pharmaceutical Industries and Associations, a lobby group. "With all these clauses, cross-border research will face a lot of challenges in trying to comply." Health research will be particularly affected by the GDPR, *Research Europe* heard, but the social sciences and diverse other fields are also expected to feel its effects. Marie Timmerman, EU legislation and regulatory affairs officer at Science Europe, and Alea Lopez de san Roman, policy officer at the League of European Research Universities, both say they fear the rules will cause problems for projects that span different member states.

And there is also a lack of clarity on how countries will proceed over the next two years—meaning universities are in limbo, says Lopez de san Roman. "The GDPR is so complex, that first we are trying to understand the possible consequences and then we are waiting for the reaction of the member states to see how they legislate at the national level," she told *Research Europe*. "We're waiting, and the clock is ticking."

Expert panel being set up for shaping the future European Innovation Council (EIC)

The Commissioner for research and innovation Carlos Moedas is in the process of setting up a 12 member expert panel to drum up ideas for the new EIC. It has been underlined that EU wants to support innovation through start-ups and innovators with potential to scale up. The Commission wants to create better mechanisms and to promote disruptive innovation. Practically the Commission will also be providing a single portal for accessing all relevant EU funding programmes. Commission proposes first research partnership in the Mediterranean to increase food and water sustainability

The Commission has presented a proposal for a Partnership for Research and Innovation in the Mediterranean Area - <u>PRIMA</u>. The first partnership of its kind in the Mediterranean basin aims to develop much-needed <u>novel solutions for sustainable water management and food production</u>.

Carlos Moedas said: "EU research and innovation is open to the world so we can tackle global challenges together. This Euro-Mediterranean partnership is an excellent example of where pooling knowledge and money can make a huge difference. It will bring more clean water and food to the people, boost local economies and create jobs. Through PRIMA, research and innovation will play a crucial role in addressing the root causes of migration."

The Commission's proposal already includes Cyprus, the Czech Republic, Egypt, France, Greece, Israel, Italy, Lebanon, Luxembourg, Malta, Morocco, Portugal, Spain and Tunisia. The participation of Germany is currently under negotiation. As the initiative is evolving over time, more participants are expected to follow, both EU and non-EU countries.

Funding for the 400 million EUR partnership will come from the participating countries (currently around 200 million EUR), matched by a 200 million EUR contribution from the EU through H2020. The partnership is scheduled to run for 10 years, starting in 2018.

Based on a <u>proposal of nine Member States in 2014</u>, this partnership will be created under H2020 and based on <u>Article 185 TFEU</u>, which enables the EU to participate in research programmes undertaken jointly by several Member States.

The Commission's proposal will now be sent to the European Parliament and the Council of the EU for political discussion and legislative approval.

Open Science and modernization of EU copyright rules

Three members of the European Commission joined the ERRIN working group meeting on Opening Science to detail further upon open access and the modernisation of the EU copyright rules. Ron Dekker from DG Research and Innovation, a seconded national expert from the Netherlands, explained the Commission priorities on open science as established by the Regulation for H2020 Open Science. The EC priorities center around (i) Reward systems (ii) Measuring quality and impact: altmetrics (get rid of the publish or perish culture) (iii) Changing business models for publishing (iv) FAIR* open data (v) Open Science Cloud (vi) Research integrity (vii) Citizen Science (viii)Open education and skills. Mr. Dekker underlined that open access is not the same as global access; the point will be to make as much research available as possible to peers. Foundations such at the Wellcome Trust and the Bill Gates Foundation have already proven that funder are in a unique position to redirect research towards open models and these examples have inspired the ambitions of the EC. The EC plans to include data management plans to be a compulsory element of future proposals. The plans must outline what data will be collected, what data will be open for others and what data will not be accessible. The data management part of the proposals will be fully eligible. Anneli Andresson and Emmanuelle Du Chalard, policy officers from DG CONNECT presented the main elements of the modernisation of the EU copyright rules. The copyright package adopted on 14th September 2016 is a large package with both regulation, directive and



positions. The main objectives of the package are to (i) Modernise the rules on key exceptions mainly in relation to teaching, text and data mining as well as preservation of cultural heritage. (ii) Facilitate licenses in order to ensure access and (iii) Ensure fairer rules for a better functioning of the copyright market place.

Commission Work Programme: Parliament debates EU priorities for 2017

The European Commission presented its Work Programme for the coming year in Strasbourg 25th October. Along with the presentation of 21 new key initiatives, the Commission Vice-President Frans Timmerman emphasised that in the coming year there will be focus on implementation and enforcement of the priorities of the Work Programme 2017. During the plenary session, the MEPs got the chance to voice and discuss the aims and priorities of the Work Programme. The concerns and issues highlighted by the MEPs included subjects of social dimensions of EU policies, investment, trade, migration and security as well as urgent political challenges of BREXIT and CETA.

As a new initiative, the agreement between the Commission, Parliament and Council of next year's Work Programme will be written down in a joint declaration.
